A5: Here is the order in which the work shall be carried out:

1. Prep work by the general contractor; including core drilling and running conduit
2. Turnstile installation
3. Electrical and fire alarm system connections by the general contractor
4. Installation of readers and security cabling by others
5. Testing of the turnstiles

Q6. Can you confirm the floor will be drilled by the general contractor to accept the bolts holding the unit to the floor?

A6: Yes, the floor will be drilled by the general contractor.
