SOLICITATION AMENDMENT No. 002

This solicitation amendment No. 002 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation.

- 1) The following Question and Answer has been provided:

QUESTION 1:

"Page 20 of 65, clause 1.1.3. What is Manufacturer's fabric Class C? Is Class C a particular PWGSC reference?"

Page 21 of 65, clause 1.2.3. What is manufacturer's fabric Class D referring to? Is Class D a particular PWGSC reference?"

Page 21 of 65, clause 1.3.3. What is manufacturer's Class B referring to?"

ANSWER 1:

The Classes which have been identified in the solicitation are not a PWGSC reference. They are referring to the manufactures standards. The word Class above and throughout the solicitation must be replaced with the word Grade. In relation to the Manufacturer fabric, we are looking for various quality of fabrics. Grade A refers to an entry or mid-level fabric, and the quality moves up in tiers based on the manufacturer's standard series. For example, Class D (Grade D) means we want to select from the manufactures standards, any fabric offered, ranging from Grade A to Grade D, but, the product needs to be priced in accordance with the Grade specified in the solicitation.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
