### **Solicitation Amendment #3**

This amendment is issued to respond to the following questions posed during the solicitation period:

Q1) Are proponents to include costs for traffic control in their pricing?

R1) Yes, proponents are to include the costs for traffic control in the fixed fee.

Q2) The costs for traffic control are heavily dependent on the duration of time required for inspections. This is difficult to estimate and dependent on variable outside the control of the proponents (weather, findings/observations). If traffic control costs are to be included, it would be more appropriate (and consistent with other projects with similar requirements) to have this item paid as a disbursement. Can this item be paid as a disbursement?

R2) Proponents are to include the costs for traffic control in the fixed fee.

Q3) We understand a dive inspection and report is required to be completed in the inspection for 2019. It would be more appropriate (and consistent with other projects with similar requirements) to have this item paid as a disbursement. Can this item be paid as a disbursement?

R3) Proponents are to include the costs for dive inspections in the fixed fee.
