Questions and Answers:

Question 2:

For the Application Software Architect - Level 2, mandatory technical criteria MB2.1, requires that "Each of the proposed resources must have a minimum of five (5) years experience in delivering information technology solutions as an Application Software Architect". Would the crown accept experience in a similar role as Application Software Architect (ie. Technical Architect) provided the experience claimed is similar to the scope of work found in Section 5.2 - Application/Software Architect - Level 2 of Annex A?

Answer 2:

Canada requires the experience of two (2) Application/Software Architects, Level 2 to perform the Work stated in Annex A – Statement of Work. Therefore, MB2.1 remains written as is.

Question 3:

For the Technical Architect – Level 2, mandatory technical criteria MB3.1 and MB3.2 each require a minimum of five (5) years' experience and the rated criteria RB3.1 requests Oracle Endeca Information Discovery Implementation Specialist Certification. Our understanding is that Oracle Endeca Information Discovery 2.3 released in April 2012 is end of life as of May 2016. As such it would be difficult for resources to have both 5 years of experience for the mandatories as well as the requested Certification (no longer offered). Would the crown please consider reducing the years of experience for MB3.1 and MB3.2 from 5 years to 2 years to align with the certification and experience level of typical resources on a product at this stage of its life cycle? Alternately would the crown consider reducing the Technical Architect from Level 2 to Level 1 with a corresponding decrease in experience for the mandatories from 5 years to 2 years?
