As Canada develops its requirement for the In-Service Support (ISS) of the *Halifax*-class Combat Systems (HCCS), Canada will continue to engage with industry to obtain advice and recommendations. The feedback received will be taken into consideration in the development of future solicitation documentation for the competitive procurement of the HCCS ISS contract.

The purpose of this Letter of Interest (LOI) is to invite all interested suppliers to Working Group sessions which will be held in the National Capital Region. Suppliers will assist the Government of Canada in developing key aspects of the future competitive Request for Proposal (RFP) and resulting contract by providing advice, information and recommendations.

- Suppliers are advised that any information submitted to Canada in response to this LOI may be used by Canada in the development of a subsequent competitive RFP. However, Canada is not bound to accept any Expression of Interest.
- The issuance of this LOI does not create an obligation for Canada to issue a subsequent RFP, and does not bind Canada legally or otherwise, to enter into any agreement or to accept any suggestions from suppliers. Canada reserves the right to accept or reject any or all comments received.
- Canada reserves the right to finalize, or change, the In-Service Support requirements for any reason it considers appropriate, either based upon information submitted in response to this LOI or for any other reason. Canada also reserves the right to restrict participation to the Industry Working Group sessions if deemed appropriate.
- Participation in this LOI is not a condition or prerequisite for participation in any subsequent RFP(s).
- Suppliers participating in this LOI should identify any submitted information that is to be considered as either company confidential or proprietary.
- Media cannot participate in the Industry Working Group sessions.
