SOLICITATION AMENDMENT No. 006

This solicitation amendment No. 006 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation; and

- 1) The following Question and Answer has been provided:

QUESTION 1:

Please see below additional rationale provided regarding the answers to amendment 003 and amendment 005.

ANSWER 1:

R1 –Keep present weighting/points. Rationale: Weighted at 2 points/year to a maximum of 10 points permits Resources with 5 years of relevant clinical experience to have a point advantage over an Resource with less relevant clinical experience (i.e. 2 years relevant experience) without unduly overweighting the R1 factor for Resources who may have 20 or 25 years relevant clinical experience if it was decided to weigh R1 at a maximum of 25 or 30 points for example.

R2 - Keep present weighting/points. Rationale: Weighted at 2 points/year to a maximum of 10 points permits Resources with 5 years of relevant PA supervision to have a point advantage over an Resource with less relevant clinical experience (i.e. 2 years relevant experience) without unduly overweighting the R2 factor for Resources who may have 20 or 25 years relevant PA supervision experience if it was decided to weigh R2 at a maximum of 25 or 30 points for example.

R4 - Keep present weighting but amend scoring to 3 points/year (to a maximum of 15 points). Rationale: Discussed below with R5 rationale.

R5 – Increase weighting to 15 points and amend scoring to 3 points/year (to a maximum of 15 points). Rationale: Discussed below with R4.

R4 & R5 Rationale: Amending the points/year scoring of R4 (teaching experience not related to a PA program) while maintaining a maximum of 15 points with a concurrent amendment of R5 to 3 points/year with an increase in weighting to a new maximum of 15 points (for teaching experience on a certified PA program) would be to achieve the following outcome in Resource bid solicitation scoring. R4 (teaching experience that is not related to PA program) weighted at 3 points/year would permit applicants with teaching experience as outlined in the bid solicitation up to 15 points (for the Resource with at least 5 years' experience) for teaching experience. Weighting R5 (teaching experience with a certified PA program) equally to R4 at 3 points/year up to a maximum of 15 points (for the Resource with at least 5 years' experience) for PA-specific teaching experience. In both instances this scoring/weighting recognizes the teaching experience equally versus more weight given to non-PA versus PA teaching experience. It would also give more weight to those Resources with more teaching experience (ex. 5 years vs 2 years) in either PA or non-PA teaching milieus. Furthermore, it would also recognize those Resources with a combination of teaching experience in both the PA and non-PA academic setting.
