**Clarification Questions:**

Note, clarification questions are numerically sequenced upon arrival at PSPC. A question and its answer will be provided via Buy&Sell as the response becomes available. Potential RFI Respondents are therefore advised that questions and answers may be issued via Buy&Sell out of sequence.

The following clarification question has been received. In accordance with Article 2.7 of PART I of the RFI, the clarification question and corresponding answer are provided to all potential respondents as set out below:

**Question 1**

Thank you for sending us this opportunity. Despite expecting this RFI request (350+ pages) in the summer time frame, we have quickly come to realize that the deadline to complete a sufficiently detailed proposal alike to the OSFIs expectations will be a difficult one. Specifically as the response for this RFIs fixed price solution requires a complete review and analysis of the entire Draft RFP, and subsequent evaluation of our projects and corporate references, as well as our employee consultants to be potentially deployed to the project. Lastly, we must complete an entire review of the functional and technical requirements in consideration of the proposed Microsoft Dynamics CRM solution to provide subsequent feedback.

Moreover, the short 15 calendar day response deadline has been exacerbated by summer vacation schedules and a release date prior to the beginning of the Labour Day long weekend, and has resulted in most members of the team only first receiving and reviewing the RFI on Tuesday Sept. 5<sup>th</sup>.

In order to provide a properly vetted and detailed RFI response, would the client team please consider providing an extension to September 29<sup>th</sup> as it will make a significant impact to the quality and value of responses returned to the OSFI client team.

**Answer 1**

Canada agrees to extend the solicitation closing date from September 15, 2017 to September 29, 2017 at 2:00PM Eastern Daylight Savings Time. Please note that due to operational requirements, Canada does not currently contemplate extending the RFI closing date any further.
