This amendment is raised to answer the following supplier question:

Question 1:

For the appendix streams should we submit a separate document for each region (Is Appendix A/Quebec, Appendix A/Ontario) or simply one and in the field designate which Regions we are certified for each manufacturer?

Answer 1:

Since this is not an actual RFSA process, you will not submit completed lists with manufacturers. Suppliers do not submit offers. This RFI is to examine the formatting, scope and content of the draft RFSA attached.

As for the appendices A1 and A2, we need feedback on which format would indeed be better, be it one appendix per stream or multiple per stream. With each stream having 9 defined regions, there is the potential for an SA having up to 18 appendices if both streams are offered. The question is therefore how best to avoid duplication and repetitiveness. Opinions welcome.
