***This amendment is raised to modify the following items to the solicitation:***

***1. Answer questions raised by the Industry***

***1. Answer questions raised by the Industry;***

***Question #001***

In the EFOT and last addendum row 17 in all four classes of paper (Columns N to Q), the instructions/headings should say price per pack not price per box. We ask that Canada please make that change.

***Answer #001***

The delivery pricing is established on a “per box” (or part box) basis. Paper pricing however is on a “per pack (ream) basis” as clarified in the amended text of Answer #006 from Solicitation Amendment 5. Therefore no changes will be made to the instructions/headings.

***Question #002***

With the latest addendum we are unclear as to how the delivery price would be charged. Please confirm the example below on the final price that an end user would pay:

***Example***

The price submitted for Item 1 is \$3.49/pack for 1–39 boxes (Column O). The delivery option 2 price submitted is \$0.10 for 1–39 boxes (Column O). When an end user selects Item 1 and delivery option 2, they will pay \$3.59/pack (\$3.49/pack plus \$0.10/pack).

***Answer #002***

Yes, as per the instructions the Offeror must enter a numerical value which represents its firm price for the delivery of (#) box(es) (or part thereof) of paper in accordance with the designated delivery option in dollars and cents separated by a period (23.12) without any spaces, dashes or special characters. The amount represented in this field must be lower than the amount for the same line item in the previous Column. All values submitted will be rounded to 2 decimals. Delivery should be charged as a separate line item.

For example: The price submitted for Item 1 is \$3.49/pack for 1–39 boxes (Column O). The delivery option 2 price submitted is \$0.10 for 2–39 boxes (Column O). When an end user selects Item 1 and delivery option 2, they will pay \$3.59/pack (\$3.49/pack + \$0.10/box).

***Question #003***

In row 17 and row 1, the quantity headings do not match for Columns N to Q (i.e. Column N says open box in row 1 and 1 box in row 17. Please update the headings to match.

***Answer #003***

As mentioned in Answer #001 in this solicitation amendment delivery pricing is established on a “per box” (or part box) basis. Paper pricing however is on a “per pack (ream) basis”. Therefore no changes will be made to the instructions/headings.

**Question #004**

The response in Amendment #005 did not address our question; as such, we would like to clarify our original question in different terms.

The paper industry (as described by the FSC body) treats both pre-consumer and post-consumer recycled material as equal. We ask that Canada accept both pre- and post-consumer material as contributors to recycled content.

**Answer #004**

Canada will not accept pre-consumer material as a contributor to recycled content as per UL-2771. The recycled paper is to be made from post-consumer material only.

**Question #005**

The EFOT v.4 sample evaluation still appears to have errors in the formula.

Please take a look at J22 to O22, J45 to O45, J68 to O68 and J91 to O91; the ranges in the sum formula are off by one value. As an example the formula in cell J22 the formula should be =SUM(J3:20).

**Answer #005**

The EFOT has been corrected but the updated version will not be attached to this solicitation amendment. Suppliers using this as point of reference should take note that the correct formula is =SUM(J3:J20) and the formula for all other tiers are offset by one row.
