This solicitation amendment 019 is raised for the following changes:

Q76 In response to Amendment #16 Q59, it is mentioned that fluoride concentration respects the criteria. However, the following table presents results at sampling points PE-01 (influent) and PE-07 (effluent):

The sample taken on December 6th 2016 shows uncertainty concerning the compliance with the discharge criteria. In a design context where discharge requirements must be met, a conservative value of 0.5 mg/L could be considered for this sample. In this case, we would have an average of 0.18 mg/L for the all samples, which is 1.5 times higher than the discharge criteria. Please confirm that a discharge criteria under 0.5 mg/L is acceptable for PWGSC.

A76 : The discharge criteria for fluoride remains the same despite uncertainty associated to discharge criteria compliance for the sample mentioned in the question (i.e. sampling point PE-07 on December 6th 2016).

Considering results obtained for samples taken at the same sampling point (PE-07) at other dates (a total of 9 series of sample when considering the treatment and commissioning periods), it does not appear justified to modify this discharge criteria since results were all under a detection limit of 0,1 mg/L, with exception to the December 6th 2016 sample which was under a detection limit of 0,5 mg/L. As a reminder, the results for the pilot field test are provided to bidders on an indicative basis and bidders assume full and complete responsibility for their use.

Q77 In Amendment 7, at items Q31 and A31, it is mentioned that all changes to the laws, standards or bylaws is assumed by the bidder. However, for all changes in laws, standards or bylaws, compensatory measures are provided by government agencies to allow treatment operators to comply with the new regulation. In the event of a change of law, standard or bylaw that could affect the whole contract, please confirm that PWGSC will make available to the bidder compensatory measures for an eventual modification of the treatment process and that, for the entire duration of the bidder services, including the optional years of operation.

A77. Modifying the original A31 answer (Amendment #007), PWGSC invites bidders to consult R2850D - GC5.3 on the standard acquisition clauses and conditions applicable to the Contract:

In the event of a change of law, standard or bylaw that could affect the whole contract in another field than those covered by clause R2850D (eg : environmental law / bylaw), PWGSC will adopt the same approach to assess the justification of an change request (eg : upgrading of the treatment process) presented by the Contractor. This request must be linked to the adjustments required to comply with the law / regulation change, and must be approved by PWGSC.
