1. Answer questions raised by the Industry;

Question #001

We require further clarification of your answer of \$3.59/pack to question #002 in Amendment 6 (" When an end user selects Item 1 and delivery option 2, they will pay \$3.59/pack (\$3.49/pack + \$0.10/box") as we find the example given to be contradictory or at least open to interpretation to the response to Answer #001 in Amendment 6 and Answer #006 to Amendment 5.

Please review and advise the correct price to the example below where customer is ordering 30 packs of paper.

If 3 boxes (30 Packs) on Line item 1 were ordered, would the total price of this order be:

a) (\$3.49/pack x 30 packs (3 boxes)) = \$104.70 (price of paper only) + 3 x \$0.10 = \$0.30 (delivery price); Total = \$105.00

or

b) (\$3.49/pack x 30 packs (3 boxes)) = \$104.70 (price of paper only) + 30 x \$0.10 = \$3 (delivery price); Total = \$107.70

Answer #001

The correct price example would be option a):

a) (\$3.49/pack x 30 packs (3 boxes)) = \$104.70 (price of paper only) + 3 x \$0.10 = \$0.30 (delivery price); Total = \$105.00

Question #002

Our office is preparing a bid response to this tender. We are asking for an extension, as of today because all of the paper manufacturers have sent out price increases as of Sept 13, 2017. We will need time to review and adjust our bid pricing because of these increases.

Please let me know if we can have an extension
