## **PART 1 - GENERAL INFORMATION**

### **1.1 Introduction**

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security, Financial and Other Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

### **1.2 Summary**

- i. The Royal Canadian Air Force - 2 Canadian Air Division has a requirement to train practising military Aircraft Structures technicians (ACS) to repair Advanced Composite Repair.
- ii. The language of instruction required is English.
- iii. The Advanced Aircraft Composite Repair training curriculum consists of approximately maximum of 30% theory (taught in a classroom environment and includes lectures, exercises), and demonstrations. The remaining 70% is practical application of the theory conducted at the contractor's training site using the contractor's training aids and test equipment.
- iv. This training must be delivered at a contractor's Transport Canada Approved Training Organization.

**1.2.1** The requirement is limited to Canadian goods and/or services.

**1.2.2** The Federal Contractors Program (FCP) for employment equity applies to this procurement; see Part 5 – Certifications and Additional Information, Part 7 - Resulting Contract Clauses and the annex titled [\*Federal Contractors Program for Employment Equity - Certification.\*](#)"

### **1.3 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2017-04-27) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

### **2.2 Submission of Bids**

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

#### **2.2.1 Workers Compensation Certification- Letter of Good Standing**

The Bidder must have an account in good standing with the applicable provincial or territorial Workers' Compensation Board.

The Bidder must provide, within five (5) days following a request from the Contracting Authority, a certificate or letter from the applicable Workers' Compensation Board confirming the Bidder's good standing account. Failure to comply with the request may result in the bid being declared non-responsive.

### **2.3 Former Public Servant**

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPS, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

#### **Definitions**

For the purposes of this clause, "former public servant" is any former member of a department as defined in the [Financial Administration Act](#), R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;
- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"lump sum payment period" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"pension" means a pension or annual allowance paid under the [Public Service Superannuation Act](#) (PSSA), R.S., 1985, c.P-36, and any increases paid pursuant to the [Supplementary Retirement Benefits Act](#), R.S., 1985, c.S-24 as it affects the PSSA. It does not include pensions payable pursuant to the [Canadian Forces Superannuation Act](#), R.S., 1985, c.C-17, the [Defence Services Pension Continuation Act](#), 1970, c.D-3, the [Royal Canadian Mounted Police Pension Continuation Act](#), 1970, c.R-10, and the [Royal Canadian Mounted Police Superannuation Act](#), R.S., 1985, c.R-11, the [Members of Parliament Retiring Allowances Act](#), R.S., 1985, c.M-5, and that portion of pension payable to the [Canada Pension Plan Act](#), R.S., 1985, c.C-8.

By providing this information, Bidders agree that the successful Bidder's status, with respect to being a former public servant in receipt of a pension, will be reported on departmental websites as part of the published proactive disclosure reports in accordance with [Contracting Policy Notice: 2012-2](#) and the [Guidelines on the Proactive Disclosure of Contracts](#).

### Work Force Adjustment Directive

## 2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to

enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## **2.5 Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Manitoba.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## **2.6 Improvement of Requirement During Solicitation Period**

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least five (5) days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Technical Bid (2) hard copies  
Section II: Financial Bid (1) hard copies  
Section III: Certifications (1) hard copies

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, Bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

#### **Section I: Technical Bid**

In their technical bid, Bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability and describe their approach in a thorough, concise and clear manner for carrying out the work.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings. To avoid duplication, Bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

## **Section II: Financial Bid**

**3.1.1** Bidders must submit their financial bid in accordance with the Basis of Payment - Annex B. The total amount of Applicable Taxes must be shown separately.

### **3.1.2 Electronic Payment of Invoices – Bid**

If you are willing to accept payment of invoices by Electronic Payment Instruments, complete Annex F Electronic Payment Instruments, to identify which ones are accepted.

If Annex F Electronic Payment Instruments is not completed, it will be considered as if Electronic Payment Instruments are not being accepted for payment of invoices.

Acceptance of Electronic Payment Instruments will not be considered as an evaluation criterion.

## **Section III: Certifications**

Bidders must submit the certifications and additional information required under Part 5.

## **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

### **4.1 Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### **4.1.1 Technical Evaluation**

**4.1.1.1. Mandatory Technical Criteria** - Mandatory evaluation criteria as detailed in Appendix 1 to Annex A of this bid solicitation.

#### **4.1.2 Financial Evaluation**

### **4.2 Basis of Selection - Mandatory Technical Criteria**

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

### 5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

#### 5.1.1 Integrity Provisions - Declaration of Convicted Offences

Failure to provide the certifications or the additional information listed below within the time frame specified will render the bid non-responsive.

In accordance with the *Ineligibility and Suspension Policy* (<http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html>), the Bidder must provide the required documentation, as applicable, to be given further consideration in the procurement process.

## **PART 6 - SECURITY, FINANCIAL AND OTHER REQUIREMENTS**

### **6.1 Insurance Requirements**

The Bidder must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Bidder, if awarded a contract as a result of the bid solicitation, can be insured in accordance with the Insurance Requirements specified in Annex C.

If the information is not provided in the bid, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time period will render the bid non-responsive.

## PART 7 - RESULTING CONTRACT CLAUSES

#### 7.1.2 Task Authorization

##### 7.1.2.2 Task Authorization Limit

2. In consideration of such obligation, the Contractor agrees to stand in readiness throughout the Contract period to perform the Work described in the Contract. Canada's maximum liability for work

performed under the Contract must not exceed the Maximum Contract Value, unless an increase is authorized in writing by the Contracting Authority.

3. In the event that Canada does not request work in the amount of the Minimum Contract Value during the period of the Contract, Canada must pay the Contractor the difference between the Minimum Contract Value and the total cost of the Work requested.

4. Canada will have no obligation to the Contractor under this clause if Canada terminates the Contract in whole or in part for default. Canada's obligation with respect to the portion of the Work under the Contract that is performed through task authorizations is limited to the total amount of the actual tasks performed by the Contractor.

## ANNEX A – STATEMENT OF WORK

### AIRCRAFT ADVANCED COMPOSITE REPAIR COURSE

#### 1.0 PART 1 – GENERAL

**1.1 Requirement.** The Department of National Defence (DND) has a requirement to train practising military Aircraft Structures technicians (ACS) to repair advanced composites in support of Royal Canadian Air Force (RCAF) aircraft operations.

**1.2 Terminology.** In the course of this SOW, the following term apply:

**1.2.1 Training Authority (TA).** The RCAF person, normally holding the title of Director of Air Force Training, charged with managing the Advanced Aircraft Composite Repair course and providing the funding source. This individual is responsible for most of the contract activity following award of contract to a technical training facility.

**1.3 Scope of work.** The contractor must deliver:

i) a training course in Advanced Aircraft Composite Repair for up to twenty four (24) military aircraft structures technicians per year; across four (4) serials per fiscal year, each with 6 students (One serial per quarter (eg 15 Feb, 15 May, 15 Aug, 15 Oct). Course start dates to be mutually agreed to upon contract award.

ii) each serial will be two (2) weeks to three (3) weeks maximum; and

iii) each serial must be approximately 30% theory including lectures, exercises and demonstrations; and 70% practical application of theory; and

iv) provide course administration, facilities, training materials and equipment;

**1.4 Target Population.** Each candidate will be qualified journeyman (QL5A) and be employed in the composite repair environment.

**1.5 Language of Instruction.** The language of instruction is English.

**1.6 Right to Inspect.** DND reserves the right to inspect the proposed training facility prior to and after awarding of the contract.

#### 2.0 PART 2 – REQUIREMENTS

**2.1 Course Conduct.** The contractor must conduct an Advanced Aircraft Composite Repair course in accordance with a schedule as agreed between the TA and the contractor for up to twenty four (24) military students per year. The contractor must coordinate the work of all students and provide transportation to and from practical course assignments (i.e. field trips), which occur away from campus, if and when applicable.

**2.2 Course Facilities.** The contractor must be an approved and accredited training facility for Advanced Aircraft Composite Repair training in accordance with any and all applicable provincial regulations. The contractor must provide appropriate classroom facilities and fully equipped training labs to adequately train up to six military student(s) per session.

- 
- 2.3 Course Instructing staff.** The contractor must provide instructors having a thorough knowledge of Advanced Aircraft Composite Repair in the Aerospace industry. With a minimum of three (3) years' experience in delivering Advanced Composite Training.
- 2.4 Course materials.** The contractor must provide all required course materials, such as textbooks, handout materials and supplies for effective course conduct.
- 2.5 Course equipment.** The contractor must provide all required equipment, training aids, special tools, personal protective equipment and consumables for each candidate during each phase of training.
- 2.6 Performance Evaluation.** Each student must be independently assessed. This assessment must be provided within 14 days of the completion of each serial indicating, at a minimum: pass/fail status and rationale behind the student's final grade. Bidder to provide Assessment Plan with solicitation.
- 2.7 Course Evaluation.** Lesson plans and Training Timelines for each topic must be provided at solicitation.
- 2.8 Student evaluation.** Each student must be independently assessed. Bidder to provide Assessment Plan at solicitation.
- 2.9 Student Accommodation.** The contractor shall provide a list of recommended accommodations and eating facilities close to the training institution as per 2.10.
- 2.10 Pre-course Information.** The contractor must prepare pre-course information packages or an online version link for each student, to include items such as the course outline and information on accommodation, restaurants, contact information, registration procedures, recreational facilities, local-area maps, bus schedule, and preparation-for-the-course instructions/materials as required.
- 2.11 Course Certificates.** The contractor must present graduation or achievement certificates to successful candidates. Copies of the certificates shall be provided to the TA by emailing: +AF AETT Resources@AF TRG@Winnipeg. The TA will have the RCAF MITE course coordinator enter the qualifications into the student's records. Certificate design must be approved by the TA prior to the end of the first serial.
- 3.0 PART 3 – COURSE SPECIFICATION**
- 3.1 General.** In general terms, the course must prepare the student to work independently to complete Aircraft Advanced Composite Repair.
- 3.2 Training Requirements.**
- a) Repair Advanced Composite Surface Damage;
  - b) Repair Sandwich Laminates;
  - c) Repair Composite Panels with Fabricated Patches;
  - d) Utilize Special Fasteners in Composite Material (to include drilling into composites and fastener procedures);
  - e) Repair Radome Composites (to include Class II honeycomb panel repair); and
  - f) Apply and Repair Lightning Protection.
- 3.3 Student Evaluation.** Each student must be independently assessed. Bidder to provide Assessment Plan at solicitation.

#### **4.0 PART 4 – Staff Code of Conduct**

**4.1** The contractor's must adhere to an Employee Code of Conduct in the workplace, including the following:

- i. Relationships with students
- ii. Confidentiality
- iii. Conflict of Interest
- iv. Harassment and Discrimination

**4.2** The contractor must provide the following for each serial of training:

- a) A proper training environment to include:
  - i. located within the contractor's site, except as otherwise approved;
  - ii. facility security system;
  - iii. furnished adequately, access to break-out rooms and
  - iv. ancillary services (restrooms, water, and sick room).
- b) Bidder must demonstrate that all specific and special equipment plus training aids are available at the contractor's site for day one of training;
- c) A detailed introductory briefing to the students at the beginning of each serial. This briefing must include:
  - i. safety and administrative topics unique to the contractor's site, (e.g. a map of the training site, site activities, a site calendar);
  - ii. summary of the organization's training capabilities, experience, and the trainer(s) qualifications;
  - iii. an outline of the course schedule, objectives and the training methodologies of used in the course delivery; and
  - iv. participants responsibilities, including attendance, assignments, and code of conduct.
- d) All necessary textbooks and course material in English. All course study material must be available to the student during study hours, in and outside of the classroom;
- e) All necessary consumable items and materials for the contractor's delivery, and the students' receipt, of the training program;
- f) All required contractor personnel for oversight of students during the practical exercises;
- g) The contractor must provide a minimum of 6:1 student to instructor ratio for theory, and 3:1 student to instructor ratio for practical. This ratio may be further impacted dependent on the safety risks involved given the training, the difficulty of the task being completed and the quantity and type of equipment being used;
- h) Oversight of absenteeism, tardiness or other disciplinary problems. This information must then be provided to the TA within 24 hours;
- i) Detailed written reports on student failures must be provided to the TA. Notice of any academic, disciplinary or administrative problems encountered by individual students shall be provided within 24 hours. Attendance and satisfactory performance are mandatory for DND sponsored students; and
- j) The contractor must ensure the DND sponsored students have access to all normal student services provided by the contractor at no additional cost to the students.

## ANNEX C INSURANCE REQUIREMENTS

### A. Commercial General Liability Insurance

1. The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.
2. The Commercial General Liability policy must include the following:
  - a. Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.
  - b. Bodily Injury and Property Damage to third parties arising out of the operations of the Contractor.
  - c. Products and Completed Operations: Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.
  - d. Personal Injury: While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.
  - e. Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
  - f. Blanket Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.
  - g. Employees and, if applicable, Volunteers must be included as Additional Insured.
  - h. Employers' Liability (or confirmation that all employees are covered by Worker's compensation (WSIB) or similar program)
  - i. Broad Form Property Damage including Completed Operations: Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.
  - j. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.
  - k. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.
  - l. Owners' or Contractors' Protective Liability: Covers the damages that the Contractor becomes legally obligated to pay arising out of the operations of a subcontractor.
  - m. Advertising Injury: While not limited to, the endorsement must include coverage piracy or misappropriation of ideas, or infringement of copyright, trademark, title or slogan.
  - n. All Risks Tenants Legal Liability - to protect the Contractor for liabilities arising out of its occupancy of leased premises.
  - o. Sudden and Accidental Pollution Liability (minimum 120 hours): To protect the Contractor for liabilities arising from damages caused by accidental pollution incidents.
  - p. Litigation Rights: Pursuant to subsection 5(d) of the [Department of Justice Act](#), S.C. 1993, c. J-2, s.1, if a suit is instituted for or against Canada which the Insurer would, but for this clause, have the right to pursue or defend on behalf of Canada as an Additional Named Insured under the insurance policy, the Insurer must promptly contact the Attorney General of Canada to agree on the legal strategies by sending a letter, by registered mail or by courier, with an acknowledgement of receipt.

2. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.
3. The following endorsement must be included:

Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of cancellation.
