Yes, any substitutions must be fully equivalent in fit, form and function. They must be approved prior to bid closing. b.No, we are not looking for proposals, this is an Invitation to tender to build a vessel as designed and specified.
4		SOW	Q. As the drawings are for guidance and we have reviewed the drawings and feel we may want to do our own lofting for the vessel. Is this acceptable?	A. Yes, it is acceptable that you do your own lofting however the critical point of this vessel design is the Gross Registered Tonnage must be as close as possible to 5 GRT without exceeding the value. The bidder must be prepared to guarantee that by doing their own lofting, their vessel will meet this mandatory requirement.

Please confirm that the contractor is responsible to develop a complete set of engineered for construction drawings for TC approval and be responsible that the vessel meets all of the criteria as stated in the SOW including stability and other performance criteria	A. The Contractor is not responsible to develop drawings. As per the SOW 5.1.2.3, the Contractor must report any deviation

				from the guidance drawings to the Technical Authority to enable the production of As-Built drawings <u>by the Owner</u>
6	5.1.2		Item 5.1.2 the requirement is for all documentation to be in French and English. Is it possible to waive the French language requirement for all or any of the documents listed? Many items may not be readily available in French language and may require direct translation that can be very expensive and outside of our expertise. If the French language requirement cannot be waived could it be a separate contract outside of this solicitation.	See revision #2
7	3.10	SOW	3.10 states electrical installations must be to transport Canada TP127E and section 4.5 states we are to work in accordance with ABYC standard. What standard applies?	The electrical installation shall be in accordance with TP 1332 and ABYC standards.
8	4.5.1	SOW	4.5.1 states using 4 batteries then goes on to say they are to be connected in 3 series pairs resulting in 24VDC , 594 Ah which would mean 6 batteries are needed. How many batteries are required?	The installation should comprise of 6 batteries providing 594Ah.

The searchlights shall feature a standard base with lever controls below. The lights shall be enamel finish. Code word '**Redan-E, White**'.
