Question 1

Please advise if the dimension of (19" x 3.5" x 15) is acceptable for the Type 1 amplifier.

Answer 1

No, the required dimensions of the Type 1 amplifier will remain as detailed in RFP Part 4 "Evaluation Procedures and Basis of Selection", section 4.1.1.1 "Mandatory Evaluation Criteria", and in Annex "A" Requirement.

Question 2

Please advise if it is acceptable for the amplifier to meet the MIL-STD-202F (method 214) for the Shock and vibration characteristics instead of MIL-STD-810F.

Answer 2
