**This Amendment 002 is raised to amend Request for Proposal M7594-177897/A as follows:**

The following changes in the RFP documents are effective immediately. This amendment will form part of the Agreement documents.

**Part A: Questions**

In response to Questions received during the tender period

**Question 1**

In Section 3.2.1 and 3.2.2, the RFP states that the projects must have been undertaken within the last 5 years. Our team would like to request that the requirement be revised so that projects undertaken within the last 10 years will be permitted. We have relevant experience from past public safety clients in training facilities that are applicable to this project, however these projects were not undertaken within the 5 year limit.

**Response 1**

The 5-year relevant experience requirement will not be changed.

**Question 2**

Our team was selected for the design and build of the Alberta Public Safety & Law Enforcement Training Centre in 2011. This facility incorporated several active training components, however the provincial government cancelled the project 2/3 through working drawings. We feel that the functional program of this project is very relevant to the RCMP Integrated Training Centre and would like to confirm whether or not a cancelled project would be permitted for the purposes of this RFP.

**Response 2**

All relevant experience, undertaken within the last 5 years, will be considered when evaluating proposals.

**Question 3**

On page 4 of 76, sentence .2 of 2.2.3, there is refer to two Synthetic Ranges. Please provide a definition for Synthetic Ranges? Does this refer to Ranges using non-lead ammunition and/or does it refer to specialized shooting simulators or both.

**Response 3**

A synthetic range is a range for fire arms training that does not use live ammunition.

**Question 4**

Is the project going to be CM at risk or CM not at risk?

**Response 4**

The project will be CM semi-at-risk.

**Question 5**

As the project will be tendered as a CM project, what is the expected number of tender packages?

**Response 5**

The number of tender packages has not been determined yet. The CM will provide input into the packages required.

**Question 6**

Does PWGSC expect the CM to undertake costing? And if yes, is a quantity surveyor still required as part of the consultant team?

**Question 7**

Is it possible to have the CM on board earlier in the design process (ex. Schematic design) as they can have significant input into phasing?

**Response 7**

Preparations of the CM RFP are currently underway and will be awarded as soon as possible.

**Question 8**

Can PWGSC clarify the expectations for meeting the intent of LEED Gold, without registration. Ex. Will the consultant team be expected to undertake the documentation during CA to show that the contractor met their points?

**Response 8**

Yes, the consultant will be required to document how the design and construction has met the intent of LEED Gold.
