A. CHANGES

Change 129:

At ATTACHMENT 1 TO PART 4 – TECHNICAL EVALUATION, 3. Mandatory Criteria M1:

DELETE:

The Bidder must provide **three (3)** Reference Projects in total. **Two (2)** of the three (3) Reference Projects must be similar to that of ANNEX A, Sections 2 through 7. All Reference Projects are to have been completed within **fifteen (15)** years of the date of Bid Closing and have a public-facing internet-based information exchange component. For all Reference Projects the Bidder must have been contracted to provide services including Business Process Re-engineering and Change Management for a business systems transformation project, from high level business requirements through to an operational, Customer accepted solution.

INSERT:

The Bidder must provide **three (3)** Reference Projects in total. **Two (2) of the three (3)** Reference Projects must be similar to that of ANNEX A, Sections 2 through 7. B. QUESTIONS

Question 224:

If a firm has already previously submitted a FOCl to PSpC would that be sufficient to satisfy the FOCl requirements, or will a new submission be required?

Answer 224:

This is determined by the Canadian Industrial Security Directorate (CISD) of PWGSC, on a case-by-case basis, and depends on factors such as the length of time since the FOCl evaluation was last completed, and what types of classified information were involved in the previous FOCl evaluation.

Question 225:

M4 Customer References indicates: *For each Reference Project provided in response to M1, M2 and M3, the Bidder must complete Form 2 to Part 4. The client contact may be contacted to validate the information provided in the Bidder's Response, in accordance with Part 4.2.4, Reference Checks.* Given that M3 does not require a project reference, please confirm that M4 should not include M3 in the list of required references.

Answer 225:

Please refer to the response to Question 214 in Amendment 011.

Question 226:

R1 states that "The Project Schedule is requested to be delivered in MS Project 2013 or higher and must address the constraints identified throughout ANNEX A. The schedule must assume a start date of September 1, 2017 and respect a production launch date of March 31, 2019." Could the Crown please clarify that these dates are to be assumed still given the bid closing date has been moved numerous times?

Answer 226:

The Crown will make no changes to the dates as previously identified. For additional information please refer to Change 78 in Amendment 008. With respect to the proposed Project Schedule that will be evaluated, the Bidder, at a minimum should include the key activities as outlined in APPENDIX 2 TO ANNEX A. In addition, the Bidder should maintain the duration as identified for the Solution Pilot activity in their proposed Project Schedule.

Question 227:

In the Corporate References criteria, the Crown requires that at least one of the reference projects must have been initiated and completed within five (5) years of the date of Bid Closing. Given that the due date of this RFP response has moved multiple times, will the Crown consider using the original bid closing date of May 31, 2017, rather than the current bid closing date, to ensure Bidder's references still qualify?

Answer 227:

The Crown will consider May 31, 2017 as the date of Bid Closing with respect to qualifying Reference Projects only. Please refer to Changes 129 and 130 in this Amendment 012.
