This Amendment 3 is raised to modify the items identified below.

1) Replace Section 3.4.2. with:

Each Response:

- a. must be received at the Delivery Address before the Submission Deadline; and
- b. should contain all Forms and Certifications required by Appendix B (B-1 to B-5).

2) Replace the second paragraph of Section 3.5.1. with:

If any of the above required forms (B-1 – B-5) are missing or submitted to the Procurement Authority but not duly completed, the Procurement Authority will request that the Respondent duly completes and submits them to the Procurement Authority within a timeframe specified by the Procurement Authority. Should the Respondent fail to complete and submit any of the said forms within the specified timeframe, the Response will be considered non-compliant.

3) Replace Section 4.1.3. with:

If the information provided by the Respondent in its Response cannot be verified and/or validated to the Procurement Authority's satisfaction, said information will not be evaluated.

4) Replace Section 4.2.1. with:

An Evaluation Committee will be appointed by the Procurement Authority. The evaluation of Responses will be carried out in accordance with the RFQ by the Evaluation Committee with assistance from other persons as the Evaluation Committee may decide it requires, including technical, financial, legal or other advisors. Assistance from technical, financial, legal or other advisors will be in response to a request from the Evaluation Committee.

5) Replace Section 4.2.2. with:

The Evaluation Committee will conduct a completeness assessment for the purposes of determining whether all of the documents required to be submitted as part of the Response have in fact been submitted by the Respondent, in accordance with Sections 3.5.1 and 4.1.2. The Evaluation Committee will then continue with its assessment with respect to whether the Respondent is a Qualified Respondent pursuant to Section 4.3. After the assessment under Section 4.3 is complete, the Evaluation Committee will rank the Qualified Respondents by the scores given to their Responses and proceed to the next stage of the RFQ process as set out in Section 4.4.

6) Replace Section 4.4.4. with:

If any of the three (3) highest ranked Qualified Respondents fail or refuse to execute the Submission Agreement within the allocated period, the Procurement Authority will withdraw the invitation and extend it to the next highest ranked Qualified Respondent to execute the Submission Agreement, and participate as a Proponent under the RFP in accordance with the Submission Agreement.

7) In APPENDIX C – RATED EVALUATION CRITERIA AND SUBMISSION REQUIREMENTS, add the sentence “Projects do not have to be completed to be submitted as reference projects.” for each of the following:

A-2 Experience Working Together, Submission Requirements;

B-1 Experience, Submission Requirements;

C-1 Experience, Submission Requirements;

D-1. Experience, Submission Requirements; and

E-3 Financing Experience, Submission Requirements.

8) In APPENDIX C – RATED EVALUATION CRITERIA AND SUBMISSION REQUIREMENTS, B-1.1 Comparability, Item 1, replace “climate” with “climate (weather conditions)”.

9) In APPENDIX C – RATED EVALUATION CRITERIA AND SUBMISSION REQUIREMENTS, E-5 Ability to Secure Guarantees (bonds or letter of credit) and Obtain Insurance, Submission Requirements, Paragraph 1 replace “If available, Construction and O&M Prime Members can provide:” with “If available, Construction and O&M Prime Members should provide:”

10) In APPENDIX D – APPLICABLE SCALES FOR RATED EVALUATION CRITERIA, Scale D-1 Reference Project Comparability, replace the description of a rating of Outstanding (5) with:

The reference project presented exceeds the definition of comparability to the Project as required by the criteria. No Weaknesses or any Weaknesses are far outweighed by Strengths.

11) In APPENDIX E – RFQ STANDARD INSTRUCTIONS, Section 10.1 replace “Without limiting any other provision of this RFQ, Canada may, at its sole discretion, disqualify a Response:” with “Without limiting any other provision of this RFQ, Canada will disqualify a Response:”

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
