To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received until now:

Question 1: Ref: 5.1.3 Radio Equipment Certification and Annex D - DND 552 FORM - Application for Spectrum Supportability

There is the information to be provided in DND 552 form that we cannot complete. For example, in Part 1 "Equipment Usage", in our view, this entire part should be completed by the radios end-user, the Department of National Defence (DND), and not by the Bidders; could you confirm?

Answer 1: The first sentence of paragraph 2) of Certification 5.1.3 is changed as follows (Part 1 of 552 form will be completed by DND):

- Delete:	2) A copy of the DND 552 Form, "Application for Spectrum Supportability" duly completed. The form will be submitted to DND Frequency Spectrum Management (FSM) for evaluation. Anticipate approximately 4 to 5 weeks for evaluation. Please refer to Annex D for a copy of DND 552 form, "Application for Spectrum Supportability" and Annex E for the associated instructions.
- Insert:	2) <u>A copy of the DND 552 Form, "Application for Spectrum Supportability" with Parts 2 through 4 duly completed.</u> The form will be submitted to DND Frequency Spectrum Management (FSM) for evaluation. Anticipate approximately 4 to 5 weeks for evaluation. Please refer to Annex D for a copy of DND 552 form, "Application for Spectrum Supportability" and Annex E for the associated instructions.

Question 2: Ref: Annex A, Section A.6:

The radio receiver must be sensitive enough to enable communication at a minimum LOS range of 5km within the specified frequency bandwidth and at a 5W transmit power;

Can you please confirm that in this case, an “LOS range” also implies that there is no barrier between the transmitter and receiver (mountain, valley, building, trees, etc.) and that there was no interfering signal or noise and atmospheric disruptive. The antenna used must be the whip antenna of 1 metre specified in item # 4 in Section A.5 of Annex A?

Answer 2: **The radio receiver must be sensitive enough to enable communication at a minimal LOS range of 5km, using a 1 meter whip antenna, within the specified frequency bandwidth and at a 5W transmit power under normal condition, meaning no obstacles such as mountains, valleys, dense vegetation, tall building and no electrical interferences.**

All other terms and conditions of the solicitation remain the same.
