1. QUESTIONS AND ANSWERS

Q1. Drawing M1 appears to be missing a large number of soundings within the largest dredge area. Will the existing grades be provided?

A1. No additional grades will be provided.

Q2. The estimated quantity of 11,000 cubic metres place measure, referenced in Section 35-20-23, appears to be much greater than a number based on the actual soundings. Please confirm how this volume was considered or its significance to this particular project?

A2. The estimated 11,000 cubic metres is taking in account Infilling and over dredging. The estimated actual amount is closer to 7,500 cubic meter place measure.
