The purpose of this amendment is to:

Part A) Respond to bidder's questions:

Question 1: In the Annex "A" Statement of Work Section **A.5.5 Specifications:**

You specify; the participant's manuals must be bound using spiral binding and/or three-ring binder;

However under A.5.5 Description Item 1: Manuals – Text / Inside pages and Covers – Bindery:

You specify; Options include assembling the gathered/collated text pages with the front and back covers, punch and spiral bind using black or white spiral binding or cerlox bound.

Is Cerlox binding a requirement or is it a client requirement or an option for the Contractor? If it is a requirement could you please provide the approximate quantities of client requested Cerlox bound books from the previous year?

Answer 1: Cerlox Binding is a requirement and the Quantities for Evaluation are as the Annex "B" Basis of Payment. Please see the revision in Part B of this amendment.

Part B) Revise the Following:

- The participant's manuals must be bound using either spiral binding and/or cerlox binding and/or three-ring binders as directed by the client;
