This APPENDIX 1 (REVISED) – COMBINED PRICE FORM supersedes any previous versions.

All other terms and conditions remain unchanged.

The following changes in the tender documents are effective immediately. This addendum will form part of the Contract documents.

ADDENDUM #1

1. The following are responses to queries submitted during the tendering period

- 1) Question: Depending on when the tender is awarded and how the weather progresses in Watson Lake (eg early freeze up), the construction may occur either when the lake is open-water or when it is frozen. How should the Bidder's anticipate these variable conditions?

Response: An Amendment is being posted to address this. Bidders should bid the Base Work assuming the lake is open-water conditions or nominally so. Bidders should bid the Optional Work assuming the lake is frozen conditions. Note that it is the Bidder's responsibility to account for all additional costs for working in frozen conditions in the Optional Work; no additional Change Orders will be allowed for frozen conditions. The Optional Work will be pro-rated against the equivalent lines of the Base Work; for example, if three-quarters of the drums are removed in open-water conditions and one-quarter during frozen conditions, then three-quarters of the drums will be paid under the Base Work line item and the other one-quarter under the Optional Work line item.

- 2) Question: If the Contractor does work while the lake is under frozen conditions, what thickness of ice should they assume?

Response: The Contractor is responsible for determining the ice thickness when to complete the Work under frozen conditions. Note that the Optional Work may be completed as late as 2018Feb15. The Optional Work includes the provision for additional Mobilization and Demobilization in the event that the work is commenced under open water conditions (Mobilization and Demobilization under the Base Work) and then remobilizes to the Site later when the lake is frozen (Mobilization and Demobilization under the Optional Work).
