QUESTIONS AND ANSWERS

Question 1: For rooms payed for by individuals and not project authority, will this be on government charge cards/credit cards or personal credit cards?

Answer 1: It could be on either depending on the nature of their business.

Question 2: Is there a minimum work guarantee with this contract?

Answer 2: No. We are pretty steady in the room requirements during the period of April through October when most of our courses are at the Police Dog Service Training Centre

Question 3: It states that a minimum of 24 rooms must be available for long term stays – does this mean they must be block booked and always available for the RCMP use but will only be paid for if a formal request is placed?

Answer 3: We have a certain need when courses are on. There are four persons to a course and in the spring, we generally have three courses running. In addition, we have annual validations and some specialty courses running, attending management from various locations across the country. These can run us upwards towards this 24 number at times. We would only pay for the rooms that are required at the time and that are booked by us.

Question 4: If there is a microwave in the hotel lobby, is that acceptable instead of individual microwaves in each room?

Answer 4: No, each room must have its own microwave oven.

Question 5: As the certificate for CAA/AAA rating may be out of date and not attainable prior to bid closing, will you accept a pdf of the current hotel rating on the CAA website as proof of rating?

Answer 5: Yes, this is acceptable.

Question 6: Will the client accept additional ratings to determine hotel rating – such as Expedia and TripAdvisor ratings?

Answer 6: No, these ratings can be set by anyone and would be hard to verify.
