This amendment is being raised to extend the bid closing date and respond to questions submitted in response to solicitation 5P420-17-5201/A.

A. BID CLOSING DATE

The closing date for tender 5P420-17-5201/A, titled RFSO – Cleaning Supplies – Jasper National Park, AB, is extended from October 10, 2017 until **October 11, 2017 at 2:00PM Mountain Daylight Time (MDT).**

B. QUESTIONS AND ANSWERS

Q1. Are we able to substitute The 2 below chemicals with chemicals of equal or superior capabilities?

9	Cleaner - Eliminator 42
10	Cleaner - Eliminator 42

A1. The products would have to be of the same quality and standard as the requested product.

Q2. Will the dispensers require installation?

A2. Dispensers are not required.

Q3. For line # 18, what is the preferred colour: black or clear tint?

A3. Black

Q4. For line Item 19 – the information reads, “10-20 gallon.” What is the strength, colour and case quantity?

A4. Colour: Grey. 4 per case. Current product: Rubbermaid untouchable square (23gallon)

Q5. For Items #9 & 10 the price requested is “per litre”. As various chemicals come with different dilution ratios the price per concentrated liter would also vary and the ready to use cost would be true price of the product. To ensure fairness in evaluation, can we advise the price per end user cost in diluted liters?

A5. Yes, please price this item per end user cost in diluted litres.

Q6. For Line # 58 & 59, what is the number of rolls per case?

A6. Rolls per case does not matter in the evaluation. We have generally received cases between 12 and 24 rolls depending on manufacturer

Q7. For Item #10, can you confirm if this is a 205 litre container or an error and should be 20L container? As our vendors offer such disinfectants in 20L container typically.

A7. This is correct, the product we are requesting is offered in a 205l container

Q8. 1.2.1 Delivery location, Jasper National Park: all washrooms, Kitchen Shelters and Picnic area's

Are the deliveries of items to multiple locations or as indicated on Annex B- Basis of Payment one delivery location to #1 Compound Road Jasper, AB?

A8. The Basis of Payment information is correct, there is one delivery location #1 Compound RD. Jasper, AB

Q9. Due to the expense of delivery in more remote locations of the National Park, would Parks Canada consider a minimum order total?

A9. There will be only one delivery point.

Q10. 3.1. Offer Preparation Instructions - Section I Financial Offer, Section II – Certifications

Should we include a Technical Offer? Part 4 Evaluation Procedures 4.1 (a) indicates that the evaluation will be based on technical and financial criteria. How will the technical portion be weighted?

A10. No, you do not need to include a Technical Offer. Basis of selection will be based on SACC Manual Clause M0220T.

Q11. Annex B, Basis of Payment

Item d) Offers shall be evaluated based by totalling the extended prices of tables 1+2+3. Are tables 2 and 3 the option year 1 and option year 2?

A11. Yes, 2 and 3 are the next two years. Offers shall be evaluated based on Total Cost Year 1 + Option Year 1 Marked-Up Price + Option Year 2 Marked-Up Price.

Q12. Can we offer substitutions/alternative products?

A12. The products would have to be of the same quality and standard as the requested product
