ADDENDUM 001 TO THE REQUEST FOR PROPOSAL

Subject: Request for Proposal T3125-171016 Contract for snow removal service

The purpose of this Addendum 001 to the Request for Proposal is to:

- 1. Answer the questions received from potential tenderers;
- 2. Publish all of the information on the Government Electronic Tendering Service (GETS) website so that all potential tenderers can access the supplementary information and amendments provided.

General:

- 1. This Addendum is part of the Request for Proposal.
- 2. No consideration will be given for extras and/or changes because the tenderer was not familiar with the contents of this Addendum.
- 3. Tenderers must include this signed Addendum to their Tender.

Amendment no. 1:

1. Question : Do you have a schedule for the tenants of the parking lot during the day and night?

Answer: NO there is no schedule of use. We rent the parking 24/7. However, at night and at weekends there are fewer vehicles parked.

2. Question : What is the time required to come back to remove the snow after the parked vehicles moving?

Answer: See Clauses 5.19 and 5.20

5.19 The Contractor must carry out the removal of the accumulated snow between 6 pm and 6 am on the day of the storm. If accumulations are too large, it will be permitted to carry out the removal the following night.

The Departmental Representative may request that the snow removal operation be carried out immediately or postponed.

5.20 Vehicles in the fleet will be moved at the end of the day of the storm to allow the Contractor to carry out snow clearing and removal operations. The spreading of ice melter and/or abrasive will be performed immediately afterword to allow the vehicles to return to their designated locations. It is possible that the Contractor will have to carry out clearing following the return of the vehicles of the place where the vehicles spent the night.

3. Question : What is the time allowed for the evacuation of snow accumulated after snow removal?

Answer: See Clauses 5.17, 5.18 and 5.19

5.17 Immediately following the end of snowfalls, the Contractor will complete the clearing of surfaces and apply ice melters or abrasives if necessary.

5.18 The Contractor may store snow prior to removal in the temporary storage area identified in Section A of these specifications.

5.19 The Contractor must carry out the removal of the accumulated snow between 6 pm and 6 am on the day of the storm. If accumulations are too large, it will be permitted to carry out the removal the following night.

The Departmental Representative may request that the snow removal operation be carried out immediately or postponed.

4. Question : Is there a place on the site, where you authorize to accumulate snow during the season?

Answer: No.
