This amendment is being raised to extend the bid closing date and respond to questions submitted in response to solicitation 5P420-17-5201/A.

A. BID CLOSING DATE

The closing date for tender 5P420-17-5201/A, titled RFSO – Cleaning Supplies – Jasper National Park, AB, is extended from October 11, 2017 until **October 19, 2017 at 2:00PM Mountain Daylight Time (MDT).**

B. QUESTIONS AND ANSWERS

Q17. Can you confirm that column D – 'Estimated Usage' is based on Column F – "firm Unit Price as per requested format" i.e Item number #58 is 50,000 rolls? We need further clarification as it would make a difference to the unit price and extended total.

In some areas, the Requested Unit format is not clear in terms of the "firm unit price as per requested format" for example, #31, Are you asking for unit price per ml or per 1000ml?

A17. Per unit, it's a dispenser unit taking the 1000ml refills

Q18. Items #20-27 - Are you asking per individual pair or per 50prs/box?

A18. Per individual pair.

Q19. Item # 9,10, 63, do you want the price per Liter or per 4L?

A19. Per litre.

Q20. For item #18, do you mean perforated with holes in the bag for drainage or on rolls?

A20. On rolls. This item could be individual bags as well

Q21. Could the customer provide manufacturer name and model for Item # 2 Black Ash Shovel ? What is this item being used for? i.e. snow removal, or asphalt as the proposed product would vary based on the use.

A21. This is produced by Great West Metals, this is for removing fire ash from a fire box or pit.

Q22. Please clarify the case size for Item #62 as the unit price on pricing column is requested per case, is it 205/case or 50/pks x 205 = 10,250 per case

A22. It would be 50 per package 205 per case. If your case lot is less set your pricing to reflect a 205 case lot.

Q23. Could the customer clarify manufacturer name and part number for Item #40? Does this item have a wringer as well or is only a bucket?
