AMENDMENT 001

The purpose of this amendment is to respond to bidders questions.

Question 1:

The above noted documentation mentions the requirement of a particular security clearance for contractors to work on site. Can this clearance be obtained after the contract is issued or must it be in place in order to respond?

Answer 1:

As per Part 6, the security requirement conditions must be met following award of a contract.

Question 2:

The bid requests that the proposal be entirely in black and white. Obviously, this would mean that no creative images or images of our past work could be included. Will your office be reviewing proponent websites for more content or information?

Answer 2:

As per Part 3, to assist Canada in reaching its objectives, Bidders should use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders. Since the instructions say "should", Bidders are not obligated to format their bid using the recommended environmentally-preferable format.

Canada will not evaluate information such as references to Web site addresses where additional information can be found, or technical manuals or brochures not submitted with the bid.

ALL OTHER TERMS AND CONDITIONS OF THE REQUEST FOR PROPOSAL REMAIN UNCHANGED.
