A2) The project funding announced by the Government of Canada is a full project maximum cost estimate, which would include funding for planning, design, project management (Parks Canada) staff time, and actual on the ground construction work. Construction is often the final phase of a multi-year preparatory process. The Government of Canada does not announce what it expects to pay a contractor for a service before a competitive bidding process has occurred.
