Amendment 003 is raised to answer questions from the industry and to make an adjustment to the NPP

Q1. Our firm holds various standing offers and several are up to \$20 million Contract Value. However, in many cases we have not completed significant work and only invoiced less than \$500,000. Would those Standing Offer Contracts / Supply Arrangements satisfy this requirement? Or does the proponent have to have invoiced the customer on a single Contract for a specific Project, for providing project management services over \$5 million prior to bid submission date?

A1. The project management services must have been delivered prior to the date of closing.

Q2. Our firm holds a contract with a crown corporation for project management services. Included in our fees are "pass-through" costs associated with engaging Design Services, Construction as well as Furniture, Fixtures and Equipment. Please confirm if those costs can be included in our \$5 million total "fee" invoiced on our project. Or does the \$5 million in fees have to be exclusively for professional services associated with project management?

A2. The \$5M in fees must be directly related to professional services associated with project management.

Q3. **RT1 E Quality Assurance:** As an ISO 9001 certified company, we have an industry recognized Quality program for project management services. On other occasions we have developed a QA program for specific PSPC projects.

a. Question - Please clarify which QA approach would be most advantageous to the Crown.

A3. It is at the discretion of the proponent to specify the quality assurance process they will develop and implement for the project.
