ADDENDUM #1

Observations of the current interior conditions of the Kitsilano Coast Guard Base indicate that construction renovations are actively being conducted. All interior work has ceased until such time as the exterior building envelop has been completed. Upon completion of the exterior works the remaining interior finishes will be completed by DFO. For this tender the responsibility of the contractor is to make good as per existing condition any disturbance or alteration of the current interior finishes. If by chance there is an individually noted location where this would not be advantageous to the owner then an agreement from the owners representative is required.
