Solicitation Amendment No. 004

This solicitation is hereby amendment to provide the following questions and answers:

Q1: The RFP requires services to be delivered to all Canadian Provinces and Territories. Certain of these services may best be delivered by making use of high-performance, reliable, broadband, internet services. Such capabilities are not always assured when one is operating in the higher Canadian latitudes, when making use of available commercial ISP sources.

Does VAC require the bidders to include within their technical and financial proposals specific provisions to ensure such broadband capabilities are available, or can we assume the Government of Canada will provide such access, under its Shared Services Canada (SSC) provisions.

A1: The GOC will not provide broadband service.

The expectation is not to provide internet service where the internet is not readily available. If the client is in an area where internet services are available, then we expect the Contractor to provide services via the internet. If internet services are not available then other mechanisms must be provided, e.g., by telephone, mail or fax.

Q2: Can you please provide clarification on Canada's inclusion of 4.1.1.2 Phase I: Financial Bid with his RFP? Typically, examinations of Financial Bids are completed after Technical Bids are evaluated and deemed compliant.

A2: For RFPs with the Phased Bid Compliance Process policy incorporated, the Financial bid is assessed for completeness soon after bid closing. Phase I is not a complete evaluation of the Financial bid.

Q3: To avoid the perception of bias, would Canada consider amending its Phased Bid Compliance Process 4.1.1.1 to delaying the examinations of Financial Bids until the after evaluation and review of Technical Bids are completed?

A3: No Canada will not amend its Phased Bid Compliance Process. The process was reviewed and approved for use for specific procurements. Canada's review in Phase I will be limited to identifying whether any information that is required under the Financial bid is missing. It is not an evaluation at this time but simply a review to make sure no required financial information is missing. The financial evaluation is done at the end of the evaluation process.

Q4: RFP page 7 of 49, section 3.1 requests that bids be submitted in three separately bound sections, and specifies the number of copies for each. RFP page 9 of 49, section 3.1.4 suggests a fourth section called Additional Information, and goes on to identify certain security-related information to be provided in that section.

Is Section IV to be bound separately, and if so how many copies are required?
