The purpose of this amendment is to make the following revisions:

A) Respond to bidder's questions:

Question 2:

Part 4 and Annex "D"

Mandatory criterion M.1.1:

Does the term "Contractually bound" include an official order placed by an external client via email where the reference number is then generated by the printer's internal ordering system and not an actual contract provided by the external client to the Bidder at the time of placing the order?

Mandatory criterion M.1.1

Yes, the term "contractually bound" includes an official order that is placed by an external client via email where the reference number is then generated by the Bidder's internal ordering system.

Question 3:

Part 4 and Annex "D"

Mandatory criterion M.1.3

Would English and French versions of a manual meet the definition of "two [2] different "manuals or publications if they are delivered on different dates?"

Response 3:

Part 4 and Annex "D"

Mandatory criterion M.1.3

English and French versions (of a manual or publication) that were **produced (printed and bound) and delivered on different dates** would also meet the definition on different manuals.

Question 4:

We would need clarification regarding deliveries.

The reference document states that deliveries must be made at 373 Sussex Drive, Ottawa, ON K1N 6Z2 (at page 1).

However, the Summary (1.2 Summary) and Annex "A" indicate that " There is one (1) delivery point for the printed course materials: Asticou Centre, 241 Cité des Jeunes Blvd, Gatineau, QC".

Finally, in the pricing grid, it is mentioned that the deliveries would be made in Moncton (NB), whereas this is not mentioned in the reference document.

Could you provide clarification?

Response 4:

There is only one (1) delivery point for the printed course materials: Asticou Centre, 241 Cité des Jeunes Blvd, Gatineau, QC.

Please also refer to the revised version of Annex "B". The reference to deliveries to be made in Moncton (NB), has been removed.
