TITLE – REQUEST FOR STANDING OFFERS–NATIONAL MASTER STANDING OFFER FOR AIR CHARTER SERVICES

This Amendment No. 005 is issued to amend the Request for Standing Offers – National Master Standing Offer for Air Charter Services (RFSO) as follows:

1. Publish the complete RFSO Amendment 005 as an attachment to this document, so that the hyperlinks in the document are active:

3. Amend **7A.5.1 Standing Offer Authority** in Part 7A to amend the office number and remove the facsimile number.
4. Amend **7B.3.1 Period of the Contract** in Part 7B to extend the period of the Contract to May 31, 2023, inclusive.
