This amendment has been raised to answer questions from industry during the site visit and amend solicitation W168A-17KM18 as follows.

- Q1 Are the building to building cables singlemode or multi-mode. Are they owned by DND?
- A1 *Cable feeding all buildings regarding this subject is Singlemode and Department of National Defence (DND) owned, managed by Shared Services Canada (SSC).*
- Q2 Is the awarded contractor allowed to use the existing DND infrastructure (copper and fibrotic single mode) that runs to the various locations across the base? What infrastructure is available to the awarded contractor?
- A2 *No, the contractor will need to install their own new cables for the services.*
- Q3 Who will be responsible for running cables to the various buildings? The contractor or DND? Should the offeror include the price for running cables in the basis of payment?
- A3 *Contractor is responsible to run cable and obtain approval from RPOU on their proposed plan prior to installation.*
- Q4 For new outlets, are the installers allowed to use tracking (outside the walls) in areas where cables cannot be fed through walls?
- A4 *For new outlets where cable cannot be fed through the walls, conduit is to be used not tracking.*
- Q5 Building 22 requires satellite services for one (1) outlet. Our company does not offer satellite services, can this location be listed as optional or removed entirely?
- A5 *Satellite services are the only option available for Building 22, therefore this location will be removed from this solicitation in its' entirety.*
- Q6 Is the Crown willing to negotiate the liability clauses outlined in the General Conditions?
- A6 In Part 2 - Bidder Instructions of the solicitation it states "*Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract*". This includes agreeing to the liability clause 2010C 16 (2008-05-12) *Liability* outlined in the General Condition 2010C. Offerors that do not agree to be bound by Canada's terms and conditions will be declared non-responsive and given no further consideration.
