3) Responses to bidder questions

Q1: One note regarding the requested glazing is that many of the Kawneer dealers are now booked well into next year for the supply and installation of windows. I know the target completion date is March 1st but I was wondering what options do we have if the windows become a longer lead item (8 to 12 weeks for shop drawing approval before they are allowed to order product from the USA, minimum 4 to 6 weeks for delivery to Canada).

A1: The Contractor is obligated to perform the Work in accordance with the Contract Documents. Refer to the General Conditions and Clauses detailed in the Contract Documents section of the Invitation to Tender (ITT) and are available on the SACC Manual is available on the PWGSC Web site: <https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>

Q2: My bonding company is asking about the warranty duration for the Kits Coast Guard Station project. Normally for envelope work the warranty required is 2 years secured by performance bond and 3 years unsecured for a total of 5 years. Most of the PWGSC projects I have seen are 1 to 2 years. As it affects the bond costs, could you clarify the warranty duration for this project?



Extend roof R1 membrane at parapet cap, so as to lap continuously with exterior wall W2 sheathing membrane, per ASK002, attached


