SOLICITATION AMENDMENT 002

This solicitation amendment is raised to address the following:

- Questions and Answers

Questions and Answers

Q1: Can you provide the volume of water to be removed from the sump area via vacuum truck?

A1: Estimated at 300,000 – 330,000 litres.

Q2: Section 31 00 00 EARTHWORK:

- Item 1.4.1 – Measurement and Payment. If this item is not to be measured, how will the quantities of soils moved be tracked? The soil quantities interred in the LTU and berm are listed as estimated, therefore how will the quantities be confirmed, if work is to be performed on a Lump Sum basis?
- Item 3.3.1 – Can you confirm the volume of soil (topsoil) to be stripped, stockpiled and subsequently re-spread from the former North LTU footprint?
- Item 3.3.4.3 – Can you confirm the volume of sump gravel removed for offsite disposal?

A2:

- Interred soil was measured when placed and is assumed accurate. Berm soil quantity is estimated at a total of 500 m³ based upon height and width and estimate is assumed accurate to required degree for a cost proposal.
- The volume of soil to be temporarily stockpiled and later re-spread across the entire North and South LTU footprint will be approximately 4,100 m³ compliant interred soil and approximately 500 m³ of compliant berm material.
- Sump per as built is 8 m x 8 m x 2 m. Approximate volume of gravel used is therefore 128 m³.

Q3: Section 02 55 13 – Contaminated Soil:

- The measurement for “excavation, loading, hauling and disposal of impacted soil” is by the cubic meter (m³), however this is to be “determined from waybill-confirmed measurements upon disposal.” Since the disposal facility measures disposal by the tonne using a scale, can this item be revised to be measured by the metric tonne?
- Item 1.5.3 states “work under this section will not be measured. Include all costs in Item 00 11 22 BOPC-1, Balance of Project Costs in the Basis of Pricing Schedule.” This statement appears contradictory to the rest of this section and the Unit Price Table. Could you please confirm where costs are to be allocated?

A3:

- No revision will be made. To clarify, payment will be per surveyed cubic meters of soil removed for disposal. Waybills will be utilized to confirm disposal at licensed, accepting facility and to confirm gross disposal volume per typical weight (volume at bulk density) for appropriate soil type.
- Section 02 55 13, item 1.5.1 indicates that excavation of contaminated soil will be measured for payment by the cubic meter. Section 02 55 13, 1.5.3. states “Except as otherwise indicated...”, meaning all the other aspects related to this section not indicated in item 1.5.1, such as related administration, etc.

Q4: Is it possible to extend the bid closing to Monday October 23, 2017?

A4: No further extension will be granted.
