

Answers to Questions

- Q1. What is the TCLP #s for the lead painted materials? This is needed for landfill disposal.
- A1. Per section 02 83 10 Lead-Base Paint Abatement - Minimum Precautions, lead containing coatings must be removed. Lead analytical results and locations are indicated in the Designated Substance Survey. It is the contractor's responsibility to ensure that lead paint removed from surfaces meets the acceptance criteria and any requirements of the Contractors Designated Off-site Disposal Facility.
- Q2. As per section 02 82 00 02 page 5 1.11 Measurement for payment.
Reference to lump sum price under Item 02 82 11-1 does not coincide with annex D Lump Sum Breakdown Item #
