1. Provide a response back from Public Works and Government Services Canada to questions received from bidders.

Q1. Page 19 – 2.2 “deliveries must be made directly to the location identified by the customer” – can you let us know how many delivery locations there will be for this business?”

R1. . This requirement is for CFB Kingston, which includes locations in Kingston and in Brockville (Brockville Armoury), Ontario. The estimated number of buildings where delivery may be required for up to 50 different buildings. The actual building number and/or address for delivery will be given on each subsequent call-up as applicable.

Q2. Will the orders, when placed, be of a value of \$700 or more?”

R2. Because this is a Request for Standing Offer (RFSO), the value of individual call-ups will be determined on an as and when required basis. In addition, the estimated usages provided are for the sole purpose of establishing an evaluation tool and are based only on best estimate and in no way reflect the actual usages expected or any commitment on the part of the Crown. The Standing Offer will be limited to the actual goods ordered.
