1. Acceptable Materials:

1. "Basis of Design" indicated on the equipment schedules on Drawings M6-01 and M6-02 are noted for reference only. Materials that meet the specifications and performance specified in equipment schedules will be acceptable.

1. Add: Control valves which are in the scope of this project are specified in the contract documents including equipment schedule Drawing M6-02 and schematic diagram Drawing M7-01.

Questions Submitted to PSPC

Question # 1

In the specifications 01 35 33 part 1.7 it states: "The Health and Safety Coordinator (Registered Occupational Hygienist, Certified Industrial Specified Hygienist) must..." Can you please clarify if the coordinator must have one of the above designations?

ANSWER # 1:

The Health and Safety Coordinator does not have to be a Registered Occupational Hygienist, Certified Industrial Specified Hygienist.

However they must be qualified as per Worksafe B.C. Regulations Part 1 Definitions – Core Requirements. Excerpts:

1.1 Definitions

(1) In this Occupational Health and Safety Regulation

"*qualified*" means being knowledgeable of the work, the hazards involved and the means to control the hazards, by reason of education, training, experience or a combination thereof;
