Questions and answers

- Q1:** When I try to look up the General Instructions at the link provided in the bid documents (<https://buyandsell.gc.ca/policyandguidelines/standardacquisitionclausesandconditionsmanual/5/R>), I get a page not found error. Is the address in the bid document correct? Is there another way to access the GIs?
- A1:** The correct URL for the General Instructions is <https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/5/R>.
- Q2:** Because I can't view the GIs yet (question above), could I get the following:
- What is the name and address that you want the bid security made out to?
 - Will a 10% bid bond be sufficient?
- A2:** In response to the questions above, GI08 (2014-06-26) Bid security requirements of the R2710T (2017-09-21) General Instructions – Construction Services – Bid Security Requirements state that:
- A security deposit shall be an original, properly completed, signed where required and be either
 - a. a bill of exchange, bank draft or money order made payable to the Receiver General for Canada and certified by an approved financial institution or drawn by an approved financial institution on itself; or
 - b. bonds of, or unconditionally guaranteed as to principal and interest by, the Government of Canada.
 - The Bidder shall submit bid security with the bid in the form of a bid bond or a security deposit in an amount that is equal to not less than 10 percent of the bid amount. Applicable taxes shall not be included when calculating the amount of any bid security that may be required. The maximum amount of bid security required with any bid is \$2,000,000.

- Q3:** Due to [the delay in posting] Annex "F," and the quick turnaround from the solicitation posting and closing, would it be possible to get a 1 week extension to the bid closing?
- A3:** The solicitation period has been extended by two calendar days to Wednesday 1 November 2017.
- Q4:** Please confirm that Appendix 1A – Cost Breakdown Table, and Appendix 1B – BOPC-1 Breakdown Table, are not required with our bid submission, but will be required prior to contract award.

A4: Yes, the Appendix 1A – Cost Breakdown Table and the Appendix 1B – BOPC-1 Breakdown Table are not required by the solicitation closing date, but the assessed best value proponent will be required to submit them prior to contract award.
