2. Public Services and Procurement Canada (PSPC) has a requirement for the purchase, delivery and installation of Rotary Office Chair;
Rotary Conference Chair, Side Chair to 3rd Floor, 1550 Avenue d'Estimauville, Québec (Qc) G1J 0C7 by November 16, 2017.

3. This NPP covers a requirement to be solicited amongst the General stream of Suppliers (SA holders).

4. This requirement is subject to the Canadian Free Trade Agreement (CFTA), the North American Free Trade Agreement (NAFTA).

5. The bid solicitation is also open to suppliers who are not Supply Arrangement (SA) holders. In order for new suppliers to bid on this solicitation, the new supplier must first qualify for a SA. The process to qualify for a SA is detailed in RFSA # E60PQ-120001/E, and can be found on the Government Electronic Tendering Service (GETS) (<https://buyandsell.gc.ca/procurement-data/tender-notice/PW-PQ-959-70369>). Canada is not required to delay the award of a resulting contract pending the evaluation of an arrangement and issuance of a SA by the PWGSC Supply Arrangement Authority.
