Question 1:

Can you confirm the requirements for ATTACHMENT 5.1 – OEM CERTIFICATION FORM? Do we require signatures from Apple to submit this tender? Do we require signatures from all OEMs for all quoted equipment, software, peripherals, cabling and components as well?

Answer 1:

Yes, the signature of Apple is required to submit the tender.
The bidder must submit an OEM Certification Form for each component, peripheral and software included in the bid.

Question 2:

Can you extend the due date of the tender by 5 business days to allow for further review of the requirements?
