Question:

The following question has arisen further to PWGSC solicitation amendment 001, dated Oct 25 2017 and specifically in PWGSC response to Q2 relating to Annex H, H.2.1:

The services in the Statement of Work are such that the formation of partnerships is necessary. PWGSC has previously accepted partnerships under the Marine Sediment CTA, and previously accepted Projects implemented by partner companies (in a prime consultant role) as part of response to PWGSC Marine Sediment CTA solicitations. Will PWGSC clarify whether Projects implemented by partner companies as noted above may be submitted to satisfy H.2.1, and if not, clearly explain why these Projects will not be considered in this bid whereas they have been accepted previously.

Answer:

The response to Amendment 001 Question 2 was with respect to Subconsultants/Subcontractors (considered to be the same), not partnerships. As per that response and Amendment 001 Question 1, Subcontractors are not considered to be part of the Bidder's team and their experience is not considered. Subcontractors include companies that provide support services such as drilling or laboratory services.

Partnerships are different from Subcontractors. The Bidder can partner either formally or informally (ex. documented through arrangements such as MOU and/or Master Service Agreement) with other companies and use the experience from those other companies as part of their technical bid. However, these companies are then considered part of the Bidder's team and they are subject to all of the CTA Conditions, including the Labour Rates in the Basis of Payment. Notwithstanding any partnerships, PWGSC has a Contract exclusively with the Bidder named in their Proposal.

The Standard Instructions clausing has been part of PWGSC Request For Proposals for many years, and this is consistent with the previous Marine Sediment CTA.
