QUESTIONS AND RESPONSES

VERSION: SOLICITATION AMENDMENT #3

Question#1: Solicitation Part 4 – section 4.1 (c) contradicts 5.1.2.1 and 5.2.3.1.

Answer #1: Delete section 4.1c of the Solicitation in its entirety.

Question #2: Please clarify section A1.1.2.1 and A1.4.4.1.

Answer #2: Section A.1.1.2.1 refers to packing time. Section A1.4.4.1 refers to time to unpacking and setup.

Question #3: Will DND provide the XRS-3 X-Ray source and does it have a 4 or 5 pin connector?

Answer #3: DND will provide the XRS3 X-ray source and it has a 5 pin connector.

Question #4: Can a wire run from the X-Ray to the DR panel even when the DRPS is in wireless mode?

Answer #4: A wire can run from the X-Ray source to the DR panel when the DRPS is in wireless mode.

Question #5: Clarify if accessories are included in the weight specified in section A.1.3.1.1.

Answer #5: As specified in the Solicitation.

Question #6: Is a Provisioning Part Breakdown required?

Answer #6: A Provisioning Part Breakdown is not required

Question #7: Is the Top Level Assembly Drawing (TLAD) the only Supplementary Provisioning Technical Documentation required?

Answer #7: The TLAD is the only Supplementary Provisioning Technical Documentation required.

Question #8:

- a) How is the lowest unit price determined?
- b) Where are non-recurring costs identified?

Answer #8:

- a) The lowest unit price is determined by adding lines 3, 4, 5, 6 of the Basis of Payment and dividing by 2 (systems).
- b) Non-recurring costs are identified in line 6 of the basis of payment

Question #9:

- a) Are the labour rates in the Basis of Payment for additional training or the initial training?
- b) Where is the Training location?

Answer #9:

- a) The labour rates in the Basis of Payment are for additional training. Initial training should be included in line 6 of the basis of payment.
- b) The training location will be at 450 Croil Private, Ottawa, Ontario, Canada
