Q1) Referring to unit price item no. 11 and section 01 11 00 CL 3.3.11 - Supply 472.2 OD x 12.7 steel pipe pile.

472.2 OD pipe size is **not** a common size. The nearest common size pipe would be **457.2 mm outside diameter x 12.7mm wall thickness**.

An uncommon size would result in higher price and a longer delivery time.

Please advise if 457.2mm OD pipe can be an alternate pipe size to 472.2 OD pipe.

A1) Unit price item no. 11 and section 01 11 00 CL 3.3.11 - Supply 472.2 OD x 12.7 steel pipe pile is changed to **457.2 mm outside diameter x 12.7mm wall thickness**.
