**7.14 Waivers of Liability**

The Parties agree that any documents signed after contract award by any participants authorized by the Contract will be void ab initio and be of no effect and that the terms and conditions of the Contract including these Articles of Agreement and the General Conditions will solely govern the Parties. This includes but is not limited to any waiver or limitation of liability, assumption of risks, covenant not to sue, indemnity agreement presented by the Contractor to participants. The Parties also agree that any requirement by the Contractor for participants to sign such documents before being able to access the Contractor's facilities will be considered be a breach of contract, enabling Canada, in its sole discretion, to exercise any and all remedies.

1. The Contractor shall obtain commercial insurance, for the duration of the contract, in such forms as are consistent with its industry practice and as would be maintained by a prudent business. Such insurance, as a minimum, shall include:

2. Aviation Liability Insurance for Bodily Injury and Property Damage, arising from the use of the aircraft, in an amount usual for a contract of this nature, but for not less than \$1,000,000 per accident or occurrence.

The above-mentioned insurance policy or policies shall include the following provisions:

- a) Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, represented by Public Works and Government Services Canada.
- b) Notice of Cancellation: The Contractor's Insurer(s) will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.
- c) Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
