PART 1 - GENERAL INFORMATION

1.1 Requirement

The Department of National Defence (DND), Canadian Forces Base (CFB) Kingston, Ration and Quarters Support Services (R&QSS) located in Kingston, Ontario requires the supply and installation of new solar sunscreen roller blinds and removal and disposal of currently installed vertical blinds.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 Trade Agreements

"The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA) and the Canadian Free Trade Agreement (CFTA)."

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003 \(2017-04-27\)](#) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of [2003](#), Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile to PWGSC will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to

enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in _____ (*insert the name of the province or territory*).

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Mandatory Site Visit

It is mandatory that the Bidder or a representative of the Bidder visit the work site. The site visit will begin at [10:00 EDT](#), in [Bldg MB-37, Rm 324](#).

Bidders must communicate with the Contracting Authority no later than three (3) business days to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders will be required to sign an attendance sheet. Bidders should confirm in their bid that they have attended the site visit. Bidders who do not attend the mandatory site visit or do not send a representative will not be given an alternative appointment and their bid will be declared non-responsive. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Technical Bid (2 hard copy)

Section II: Financial Bid (1 hard copy)

Section III: Certifications (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green](#)

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1 Mandatory Technical Criteria

1. The Bidder must provide with their proposal the necessary documentation and colour swatch samples to support and demonstrate compliance with the Mandatory Technical Criteria outlined in Annex "A" attached.
2. Bidders must attend the mandatory site visit outlined in PART 2 - BIDDER INSTRUCTIONS Article 2.5.

4.1.2 Financial Evaluation

1. The evaluated price will be the unit price multiplied by the quantity to arrive at the extended price. The sum of the extended price will be the evaluated price.

4.2 Basis of Selection

4.2.1 Basis of Selection - Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

ANNEX "A" - REQUIREMENT

Solar Sunscreen Roller Blinds

1.0 Scope

1.1. Objective

The Department of National Defence (DND), Canadian Forces Base (CFB) Kingston, Ration and Quarters Support Services (R&QSS) located in Kingston, Ontario requires the supply and installation of new solar sunscreen roller blinds and removal and disposal of currently installed vertical blinds.

1.2. Background

CFB Kingston R&QSS is responsible for the up-keep of various accommodation building located within CFB Kingston. Part of the up-keep is to maintain the lifecycle management of various equipment, furnishing, bedding and window coverings located in each building. The current CFB Kingston, R&QSS Lifecycle Management Program requires that window coverings are to be rotated out of use when stained, damaged beyond repair, and on a ten (10) year cycle.

2.0 Requirements

2.1 Requirements

CFB Kingston R&QSS requires the supply and installation of four hundred and eighty-four (484) new solar sunscreen roller blinds and the removal and disposal of four hundred and eighty-four (484) currently installed vertical blinds.

The new solar sunscreen roller blinds must meet the following specification:

- a) Material - Bacterial and fungal resistant
Waterproof and fire retardant
Flame-spread rating and degree of flame resistance as per the National Fire Code
Meshed Weave - 25% Polyester, 75% PVC on Polyester;
- b) Openness Factor - 3%;
- c) UV Ray Blocking - 97%;
- d) Colour - Grey;
- e) Finish - Zenith;
- f) Bottom Rail - Silver aluminium;
- g) Mechanism - Right sidewinder;
- h) Pull Chain - Bead - Nickel plated steel;
- i) Connectors - Metal
- j) Roller Tube - Rust free aluminium;
- k) Brackets - Sized to support weight of blind plus force applied to operate blind; and
- l) Hardware (screws) - must be included to facilitate installation.

2.2 Tasks

1. The contractor must supply all labour, equipment, materials, and transportation associated with the supply and installation of new solar sunscreen roller blinds;
2. The contractor must supply all labour, equipment, materials, and transportation associated with the removal and disposal of old vertical blinds;
3. The contractor must ensure that all rooms are clean after installation; and
4. The contractor is responsible for the disposal of all packaging material.

2.3 Constraints

1. A mandatory site visit is required to confirm window measurements, install position, and quantities.
2. The installation, removal and disposal can only be done between 8:00 a.m. and 3:30 p.m. (EDT ON), Monday through Friday excluding statutory holidays.

2.4 Timeframe and Delivery Dates

1. Install dates and timings for each project location must be coordinated with the Project Authority (PA).
2. Building access must be coordinated with the PA.
3. All four (4) project locations must be completed by 30 March 2018.
