Please note that the closing date has been changed to November 20, 2017, EST.

See the following clarifications:

- 1) **At page 16 of 28 of Annex A – Requirement, under the point rated technical criteria; A2.4 Must provide a maximum variation of 1%, quoted under/below:**
As requested in item A2.4, the machine “ Must provide a maximum variation of 1%”
 - This pertains to the stability of the machine, when the machine scans the film, the horizontal variation must be equal to or less than 1%. The respondent is encouraged to provide detail specification of his unit, especially if it is greater than what is being requested.
- 2) At page 16 of 28 of Annex A – Requirement, under the point rated technical criteria; A2.4.1: 0.5% to 1%:
 - In this case, if the variation is between 0.5 and 1%, the respondent will receive points, however, if the variation is better, between 0.1 and 0.499% chances are the item will receive the maximum points allowable for this item.
- 3) At page 16 of 28 of Annex A – Requirement, under the point rated technical criteria; A2.4.2: 0.1% to 4.99%

DELETE: 0.1% to 4.99%

REPLACE BY: A2.4.2: 0.1% to 0.499%
- 4) In Attachment 2 – Evaluation Grid, at point C1.2.1, it is mentioned:
 - C1.2.1 Mandatory Requirements: It is requested that the bidder address each of the mandatory criteria stipulated in Appendix A - Requirement in sufficient detail to prove compliance. An evaluation grid has been provided at Appendix B to assist the bidder in indicating compliance, stating the attributes of the proposed equipment and indicating the location of the reference material.

- Appendix A is referred to as “ Mandatory Requirements” page 13 of 28 in the English version of the posted RFP document.

- 5) At point C2.2 Equipment Requirements (up to 95 points):

In addition, points will be assigned as designated in Attachment 2. Points will be assigned solely on the basis of the information supplied by the bidder in their bid.
