This amendment is raised to modify solicitation EW702-173131/B as follows:

1. Questions and Answers

Question 4: We would like to formally request the Giant Mine Surpac mine model files for the entire underground infrastructure that is currently mapped.

Answer 4: The Giant Mine Superpac mine model files will be distributed (on CD) at the Bidders' Conference.

Question 5: How does section "1.5 Team Identification" get submitted as it seems to be part of the bid price form, and if so, is it submitted with the financial proposal? If this is the case, it does not form part of the technical evaluation, correct?

Answer 5: 1.5 Team Identification forms part of the Bid Price Form and should be included in the "Bid Price Portion" submission. In accordance with SRE Section 1, Proposal Format, Bidder Identification is not part of the page limitation.

Question 6: There is reference to 'Construction Management Team' in paragraph 3 of SI06 but there is no definition provided in the glossary of terms on page 9 of 106. Should this term be 'Bidder' as defined in the glossary of terms?

Answer 6: Refer to "DELETE" and "INSERT" below.

Question 7: What time is the Bidders' Conference on November 16, 2017 expected to finish?

Answer 7: The Bidders' Conference is expected to finish at or before 12:00 PM MST.

2. Changes to the Request for Proposal

DELETE SI06 LIMITATION OF SUBMISSIONS in its entirety.

INSERT SI06 LIMITATION OF SUBMISSIONS

1. While there is no requirement for firms to participate in this procurement in joint venture, they may elect to do so if they see fit. However, only one submission per bidder will be accepted, whether it is submitted by a firm as an individual Bidder or by that firm as part of a joint venture Bidder. If more than one submission is received from a firm acting either individually or in joint venture, all such submissions shall be rejected and no further consideration shall be given to the firm or to any proposed joint venture of which the firm forms part.
2. A joint venture is defined as an association of two or more parties which combine their money, property, knowledge, skills, time or other resources in a joint business enterprise agreeing to share the profits and the losses and each having some degree of control over the enterprise.
3. An arrangement whereby Canada contracts directly with a Contractor who may retain sub-contractors to perform portions of the work is not a joint venture arrangement. A sub-contractor may be proposed as part of the Contractors Team by more than one Bidder.
4. Notwithstanding paragraph 3. above, in order to avoid any conflict of interest, or any perception of conflict of interest, no firm acting as an individual Bidder or as part of a joint venture Bidder, shall be proposed as a member of another Bidder's Team, either as a sub-contractor or as part of another joint venture Bidder. Failure to comply with this limitation will result in all submissions so involved being rejected.
5. Any joint venture must be in full compliance with the requirements of any provincial or territorial law pertaining thereto in the Province or Territory in which the project is located.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
