QUESTIONS AND ANSWERS

Question 1: Could you please clarify the following points regarding this solicitation:

- a) In ATTACHMENT 1 TO PART 4 – TECHNICAL EVALUATION CRITERIA point B) Point Rated Technical Criteria, “R1 Automatic sample changer combines liquid and headspace injections on one sampler so the user can switch from one application to the other on the same workstation”. And then in Annex A, point 2.1 2.1 “The GC/MS system must include an automatic sample changer that can accommodate at least twenty-five (25) different liquid samples in a standard 2ml screw top vial (12x32mm) not including any liquid injector wash or waste vials”. So, could you please clarify whether the customer wants liquid AND Headspace capabilities, or only liquid sampling?
- b) In ATTACHMENT 1 TO PART 4 – TECHNICAL EVALUATION CRITERIA point B) Point Rated Technical Criteria, “R3 Mass spectrometer includes two chemical ionization sources”. And in ANNEX A – PURCHASE SPECIFICATIONS, point “5.1 The MS must operate in electron impact (EI), positive and negative chemical ionization (CI) modes” and point “5.2 The MS source for both EI and CI must be included”. Could you please clarify whether the customer wants 2x CI sources or 1x CI and 1x EI?

Answer 1: Annex A provides the GC/MS mandatory specifications as referenced at M1 on page 9 of the bid solicitation. The point rated criteria are preferred items which are intended to differentiate bids that meet the mandatory technical criteria.
