QUESTIONS AND ANSWERS

Question 1: Is there a change to the bathroom fixtures on the main floor?

Answer 1: No, the bathroom fixtures on the main floor will not change.

Question 2: What is the type of wall construction in the cell?

Answer 2: Not certain, however assume plywood construction with wood studs.

Question 3: What is the fire rating required for the mechanical room?

Answer 3: We are looking for 1 hr fire rating for the room, including dampers where required.

Question 4: Where is the furniture going?

Answer 4: There is limited space on site for storage of furniture. Temporary swing space may be used in the secure bay with approval of local site authority.

Question 5: What are the dimensions of the second floor?

Answer 5: Not certain, approximately 7.5 m wide by 7.1 m. for second floor footprint.
